MA Department of Revenue (DOR) – Sales Tax Certificate

As stated in the February meeting notice, the MA Department of Revenue (DOR) requires those table holders at Chapter 8 Marts, who have sales tax certificates, to withhold sales tax as appropriate for the type of sale they make. Collectors and hobbyists who make “casual or isolated” sales do not have to have a tax registration.

WORKSHOPS AND PROGRAMS

9:00 AM. "400-day, Anniversary Clocks." Jeff Adams will give a brief history of this type of clock with the bulk of the talk centered on how these clocks work, common problems, and simple repairs. Since 1994, Jeff has been repairing clocks and watches. He has been a NAWCC Field Suitcase Instructor since 2003 and studied under Mr. Dan Neid, former head of the NAWCC School of Horology.

10:30 AM. Watch Measurements. Jon Weber's horological interests are precision time keeping and repair of watches particularly old Swiss and English pocket watches. Since parts are not available, he has to fabricate the parts, which can be a time-consuming process. Jon will be describing the methods and showing the tools he uses to make these measurements. He has been a watch enthusiast since 1964 and an NAWCC member since 1972 (several published NAWCC Journal papers). Jon works as an engineer at a large Aerospace company and holds five patents.

12:00 Noon. Luncheon

12:45 PM. "The Guilmet Mystery Clock." Bob Boyd's talk will explain one of the early clocks that was not only designed to tell accurate time, but to mystify and intrigue the owners and their guests. Guilmet was such a designer and his designs still intrigue today. Sometimes their operation can stump today's clock repairer. This talk will acquaint you with the operation of one of Guilmet's swinging pendulum mystery clock, explaining the imperceptible twisting movement of the statue to impulse the pendulum. An example clock will be used to see the movement as well as drawings of the motion of the movement. Bob is a retired professional engineer who specialized in the manufacture of electronic and mechanical systems with applications as diverse as elevator controls to medical testing devices. His goal in clock restoration is to return the piece to the condition that the maker intended.

Look for a message board near the registration desk where you can advertise for research information as well as for items that you want to buy or sell. Also, if you know of someone who has any interest at all in clocks and watches and would benefit by joining Chapter 8, please consider becoming a sponsor and bring them to a meeting.

TABLE VENDOR REPORTING REQUIREMENTS – MA DEPARTMENT OF REVENUE (DOR)

The term, vendor, is defined (by the MA DOR) in G.L. c. 64H as, “a retailer or other person selling tangible personal property of a kind that the gross receipts from the retail sale of which are required to collect in the measure of the tax.” “Retail sale” is, in turn, defined, “as a sale of tangible personal property for any purpose other than resale in the regular course of business.”

However, the sales tax does not apply to casual or isolated sales by a person not regularly engaged in the business of selling tangible personal property (830 CMR 64H.6.1). “Casual and isolated” sales are defined as, “tangible personal property originally acquired for use or consumption by a seller and later resold by that seller other than in the course of regular business engaged in by that seller.”

As to whom must provide evidence of MA vendor registration, those chapter members who are regularly engaged in the buying and selling of watch and clock items (and who are presumably already so registered with MA DOR) must provide such evidence (MA tax ID). Those collectors and hobbyists who are engaged in “casual or isolated” sales are not required to produce evidence of a MA tax ID registration.

The DOR regulation requires that every person, who is a table renter, must provide their name, address, and table number. For Chapter 8 to meet this requirement we will have two sections on our chapter vendors’ list: those with a MA tax ID, and those for a casual sale only. It is the responsibility of the table holder to provide the correct information, not the chapter. Simply stated, if you are in the business of buying and selling watch and/or clock items, provide your State Tax ID number on the list. If you are only a collector or hobbyist, we must only submit your name and address. We feel that most table holders, from past experience, fall into the “casual or isolated” sales category. However, it is up to you to choose the correct category.
